This Shipped Semen Contract for the breeding season of _____2010____, is made and entered into on this _____ day of _____ by and between Max & Lisa Gerdes _____ hereinafter referred to as "Stallion Owner" and _____ herein designated "Mare Owner". The Mare Owner agrees to breed the mare

to the Stallion Wildwych Eclipse, Reg.#S722 XII subject to the following.

1. The Stud Fee shall be _____\$650.00____ (LFG, Booking Fee, and First Collection) _____ of which _____\$200____ will be considered as a non-refundable booking fee. The stud fee shall be paid in full before semen is shipped.
2. All previous debts to Redbud Ranch and/or the Stallion Station Manager acting on behalf of Redbud Ranch must be paid in full before mare is bred unless otherwise agreed.
3. The Stallion manager will make all reasonable attempts to ship the semen in a timely manner, and requires a **24 hour** notice prior to collection. At this time there is no Sunday carrier pick-up and Saturday Delivery May Not Be Available in Your Area.
4. The Stallion manager/owner assumes the responsibility only to deliver live semen in viable condition at the time of delivery to the mare owner.
5. A collection fee of _____\$300.00____ will be charged each time the semen is shipped.
6. The mare owner is responsible for all shipment fees.

7. *Mare owner must obtain their own Fed-Ex account number, unless otherwise agreed. Call 1-800-GO Fed Ex. If Mare owner cannot obtain Fed-Ex account number please include ___\$300.00___ deposit for shipping cost.

8. If more than one shipment is required to settle the mare, the mare owner is responsible for all charges except additional stud fees.

9. If two or more mares are to be inseminated by one shipment, only one collection and freight charge apply.

10. The Stallion owner guarantees a live foal from this breeding. Live foal shall be defined as a foal that stands and nurses without assistance. Should the foal not stand, and nurse, the mare owner agrees to notify the Stallion owner within one week of foaling date and furnish a statement from a licensed veterinarian. The mare owner will be entitled to return the same mare for a re-breed for the next breeding season. If the mare is unsound for breeding, the mare owner may substitute another mare. The return privileges are conditioned upon mare owners' payment of the then current fees and charges, except stud fee, and upon the stallion being alive, fit to breed and owned by the stallion owner. IF the stallion dies or becomes unfit for service, then this contract shall become null and void.

11. Guarantees: ___X___LFG

12. The Stallion Owner or Manager of the stallion agrees to diligently try to settle the said mare up to and including July 1. Mare owner agrees to give stallion owner or manager ample opportunity to settle her, having bred her through at least two heat periods, or being certified in foal by a veterinarian. IF, However, for any reason she does not settle, the mare owner will hold stallion owner or manger harmless.

13. A "Breeding Certificate" will be issued for the foal, conceived by this mating when the stud fee and all other expenses have been paid in full and when the mare has produced a live foal from this mating.

14. The mare owner assumes all responsibility for the condition of the mare and shall bear all risk of loss or damage to the mare whether by death, disease, injury, infection or otherwise and by any cause whatsoever, and therefore agrees to hold stallion manager/owner harmless for any and all damages associated therewith.

15. The mare owner shall supply a copy of the mare registration showing current ownership at the time of signing this contract.

16. This contract is non-assignable and non-transferable.

17. This contract is entered into in the Sate of California and will be interpreted and enforced under the laws of that state. Should either party breach this contract, the breaching party shall pay for the other's court cost and reasonable attorney fees related to such breach.

18. This Contract represents the entire agreement between the parties. No other agreements or promises, verbal or implied, are included unless specifically stated in this written contract. Additional conditions should be written on this contract and be individually initialed by each part. If none, initial her. _____

19. When Mare Owner and Stallion Owner sign this Contract it will be binding on both parties, subject to the above terms and conditions
